    - i. There was a historical legacy of having both an MS and an MSPH in these departments
    - ii. SPHTM is in their accreditation year
  - c. MPH in Environmental Health Sciences replacing MSPH in Environmental Health Sciences notice
  - d. MS in Health Security vote
    - i. Learning outcomes were good and clear
    - ii. Passed, 16 in favor, 1 abstention
- 6. BMS proposals:
  - a. MS in Medical Science vote

- i. Learning outcomes are very different from MD to MS. Need to include those outcomes.
- ii. A way for a student who began in the MD program but isn't continuing on in that program to do a MS and get some credit for the work that has been done by completing a thesis
- iii. Passed unanimously
- b. PhD new concentration in Microbiology and Immunology vote
  - i. Learning outcomes need to be included
  - ii. Cleaning up, realized that MIIM has been functioning as though they have this concentration, making it official
  - iii. Passed unanimously

## 7. SSE proposals:

- a. MS in Chemistry, non-thesis vote
  - i. Admitting students to the terminal MS program
  - ii. We don't market as "terminal"
  - iii. If a student wants to continue, they would have to apply to the PhD program; it wouldn't be automatic
  - iv. 17 in favor, motion passes
- b. MS in Psychology Behavioral Health vote
  - i. 4+1 program exists already, proposing to open a terminal master's degree to external students
  - ii. 16 in favor, 1 abstention, motion passes
- c. MS in Psychology Psychological Science vote
  - i. 4+1 program exists already, proposing to open a terminal master's degree to external students
  - ii. 17 in favor, motion passes
- 8. Graduate Credit Transfer Policy update vote
  - a. It was purposeful to include only MA, MS, MFA. Add in MPH programs as an acceptable source of credits to transfer in.
  - b. What is the percentage of credits that could transfer from one master's degree to another? This policy is only in reference to transferring from a master's degree to a PhD
  - c. Currently, if a student comes in with a master's degree from another institution, they are able to transfer in 50% of those credits. If a student got a terminal master's degree at Tulane, they were currently only permitted to transfer in 25%, which we would like to change to permitting 50%
  - d. This does not have to be in the same major
  - e. We will create a best practices document, with examples to make sure that institutional memory is preserved

- f. Transferred credits from a Tulane degree will the grades transfer as well from a Tulane master's degree? Our experience is no
- g. Departments have ultimate discretion over whether they accept credits. This policy does not imply that 50% of a student's credits \*will\* be accepted
- h. Motioned to vote by S. Overstreet, seconded by J. Tasker. Passed with all in favor
