 - iii. We are working on making sure postdocs and their departments know their differences
 - iv. We are considering a certificate for postdocs who complete
 - f. Work on the NSF-NIH Survey of Graduate Students and Postdocs in Science and Engineering is ongoing. Impacted departments have been contacted and OGPS appreciates all assistance in completing this important survey

- i. Used by AAU to determine grad student and postdoc support
 - ii. We want to make sure all the ways we support students, such as tuition waivers, and health insurance are included
- 4. New specializations in the Master of Business Analytics (MANA) Curriculum – notice
 - a. We do not approve programs for the professional schools, but we do notify GC about them so that we can ask questions
- 5. New MS in Computer Science – vote
 - a. Department is pretty new
 - b. Has the support of SSE faculty and dean
 - c. Will this course be open to PhD students across schools
 - i. PhD students can take courses across schools but MS students can't. PhD students would be able to take this if there is room in the course.
 - d. We expect it to be a popular program because CS is growing strongly
 - e. G. Morris moves to approve, seconded by F. Wietfeldt, all in favor.
- 6. OGPS Fellows' Projects: Jaclyn Maraldo, Amanda Reusch, and Ashley White
 - a. We have three graduate students working with OGPS this year as fellows
 - b. They are supporting the office with OGPS projects and their own
 - c. Amanda: Working on communications with Jennifer and a 3-year reorientation project
 - i. Students are transitioning from consuming to producing knowledge
 - ii. It is a challenging transition for many
 - iii. Working on a canvas course that will have various resources to reacquaint students with valuable resources
 - iv. Focusing on broader issues like imposter syndrome, time management
 - v. Want to create small videos of professors talking about how they've overcome imposter syndrome and manage their time
 - vi. M. Lewis brought up confidentiality issues to make sure that faculty are confident their videos won't go too far
 - vii. We know that students have largely forgotten a great deal of what they learned in orientation.
 - viii. Also, there are a lot of practical options about fees and insurance, that have a significant impact on students' lives
 - ix. You might want to talk to faculty in SoPA about course development to make it interactive and engaging. For instance, quizzes can become polls
 - d. Jaclyn: Researching how OGPS can support PhDs and Postdocs going into non-academic careers. Looking to put together a panel of people who have made that transition successfully
 - i. Need to be put into contact with professionals
 - ii. This information will be in Canvas

- iii. BMS has an extensive database of alumni with first and second placements that could be shared
- e. Ashley: Online event with four alumni speakers who have agreed to participate
 - i. Students will submit questions prior to the event
 - ii. How COVID has impacted their careers
 - iii. Need other speakers, particularly in SLA
 - iv. There are faculty who haven't gone on a straight path
