# 7. SLA proposal

- a. 4+1 program in Political Economy with Data Analytics vote.
  - i. 3 semesters for external candidates already exists
  - ii. 4+1 program is what is up for vote
  - iii. Vote is all in favor
- b. PhD in Sociology vote
  - i. Questions about requirements
  - ii. Requirement to meet with OGPS career services is unenforceable because those meetings are confidential. We don't plan programming for internships or other career preparedness like that
  - iii. Collaborating programs. CCC funds came from the provost's office as an interdisciplinary program, those funds revert to the provost's office. Has anyone from Social Work been involved? This proposal references courses and concentrations but there are no letters of support
  - iv. CCC program is phasing out, this replaces one of those tracks
  - v. Funded by the pot of money that SLA has for stipends.
  - vi. Problem of career preparation/professional development: How does 6 semesters of fairly standard TA and RA responsibilities address that? What do the meetings with OGPS do? Could there be an internship option?
  - vii. African Studies was added in by SLA curriculum committee to make sure that the Africana Studies department was involved in the process. Those are examples of possible tracks.
  - viii. This goes into the catalog and so if a student sees all of these track options but they're not actually possible, this feels like it's not truth in advertising
  - ix. Can advertise that it is a program that is pending approval, as program wants to admit for Fall 2026
  - x. Vote was tabled until the September 2025 meeting
  - xi. Transcript/notes of meeting conversation will be sent to SLA
